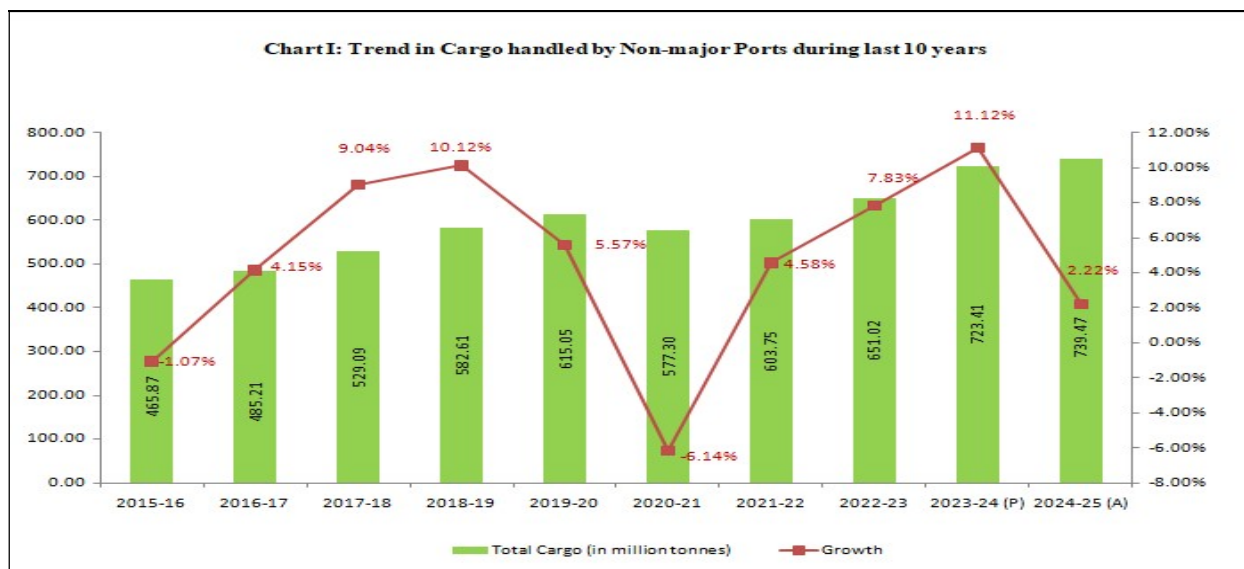


CARGO HANDLING STATUS FOR NON- MAJOR PORTS OF STATE MARITIME BOARD / DIRECTORATE OF PORTS DURING JUNE 2025

Cargo handled by Non-Major Ports in India

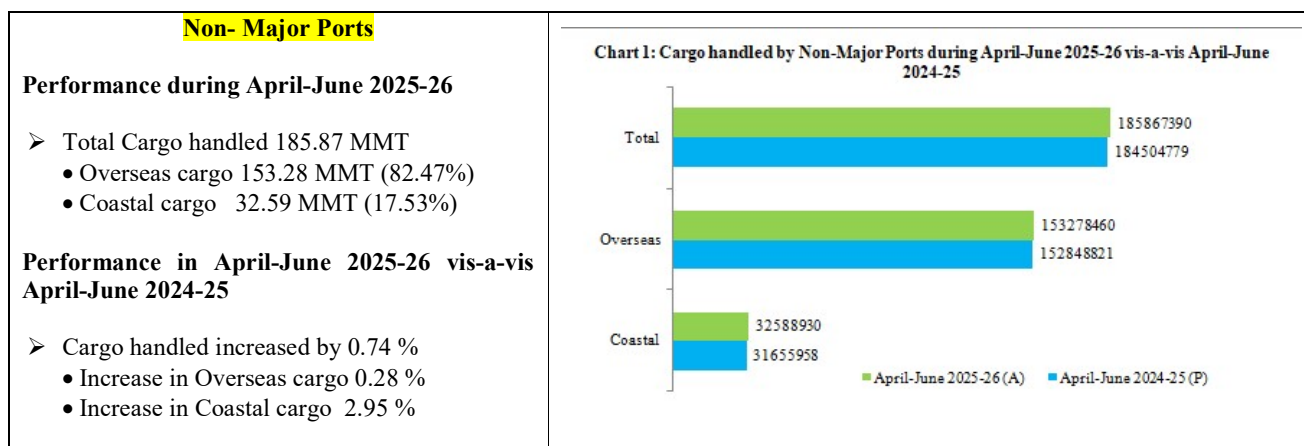
Maritime transport activity is driven by the growth in output and trade worldwide. The volume of seaborne cargo handled by ports is comprised of the global (i.e. overseas cargo) and domestic (i.e. coastal cargo) activities. There are 68 Non-Major ports, under 11 State Maritime Boards (SMB) and Directorates of Ports (DoP) which provide information on Port Data Management Portal (PDMP) of the Ministry on cargo handled by them.

This publication provides data for the month of June 2025 (Advance Estimates) compared with provisional estimates of June 2024. During April-June 2025-26 cargo handled at Non-Major Ports increased by 0.74% compared to April-June 2024-25. During April-June 2025-26 total cargo handled increased to 185.87 million tonnes (MMT) from 184.50 MMT handled during April-June 2024-25. The overall trend in the cargo handled at Non-Major Ports during the past ten years is shown in Chart-I.

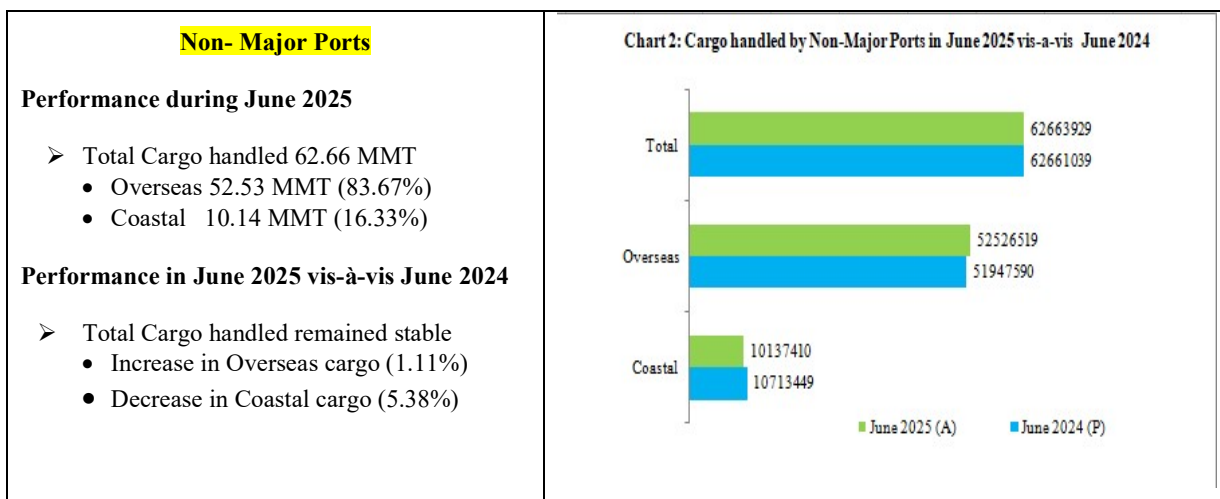

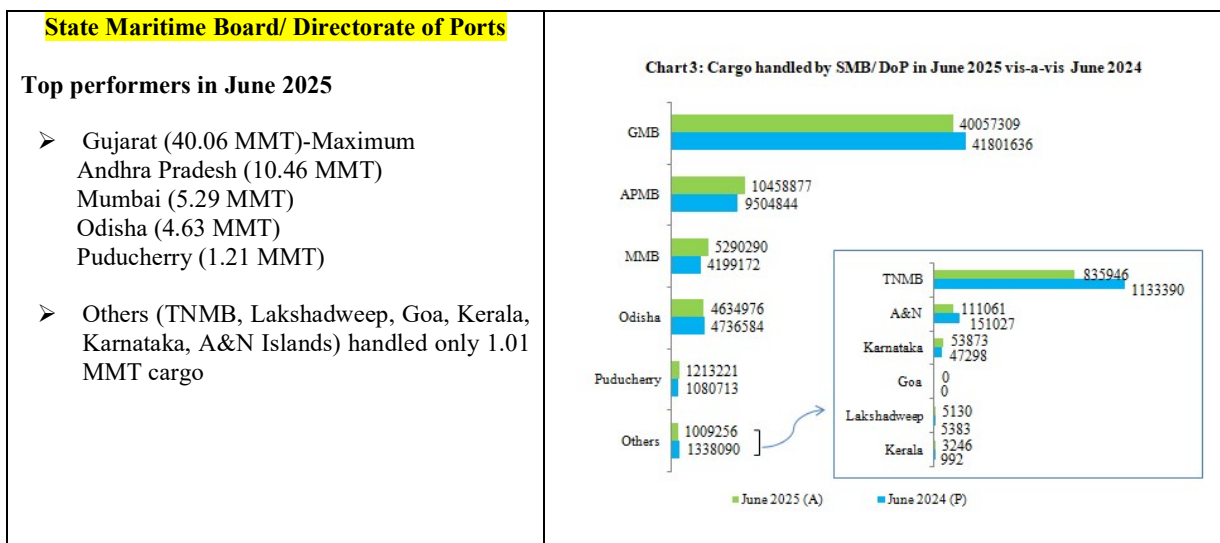
Cargo handled by Non-Major Ports during April-June 2025-26



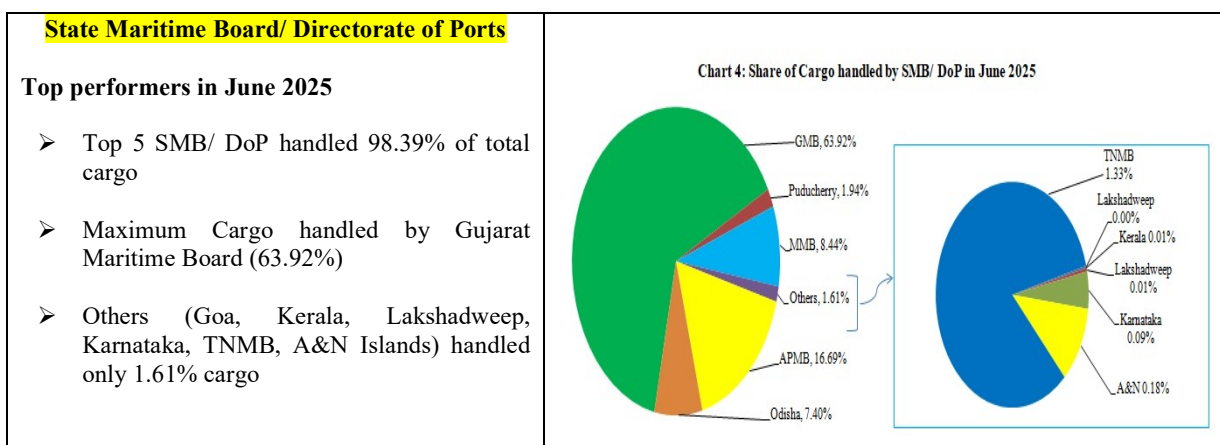
Cargo handled by Non-Major ports in June 2025

Commodity-wise Cargo handled in June 2025

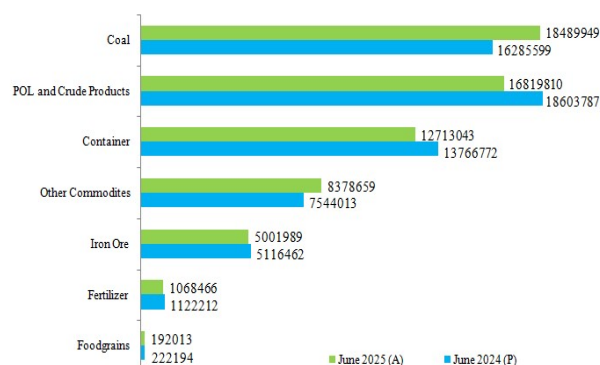
Commodities handled by Non- Major ports

Broadly commodities are categorized in 7 Principal commodities.

Progress in June 2025

- Coal had maximum share of 29.51% with 13.54%(maximum) growth.
- POL and Crude Products had cargo share of 26.84%.
- Containers had cargo share of 20.29%.
- Growth was negative for Foodgrains (13.58%), Fertilizer (4.79%) and Iron Ore (2.24%)

Chart 5: Principal Commodity-wise Cargo handled in June 2025 vis-à-vis June 2024



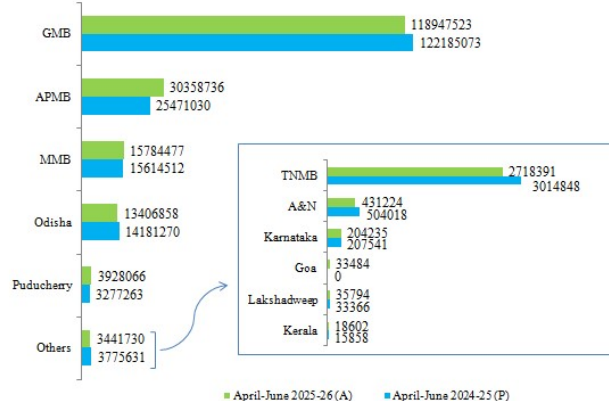
SMB/ DoP-wise Cargo handled during April-June 2025-26

Top performers during April-June 2025-26

- GMB (118.95 MMT)-Maximum
- APMB (30.36 MMT)
- MMB (15.78 MMT)
- Odisha (13.41 MMT)
- Puducherry (3.93 MMT)
- Others (Goa, Kerala, Lakshadweep, Karnataka, TNMB, A&N Islands) handled only 3.44 MMT cargo

Chart 6: Cargo handled by Non-Major Ports during April-June 2025-26 vis-à-vis April-June 2024-25



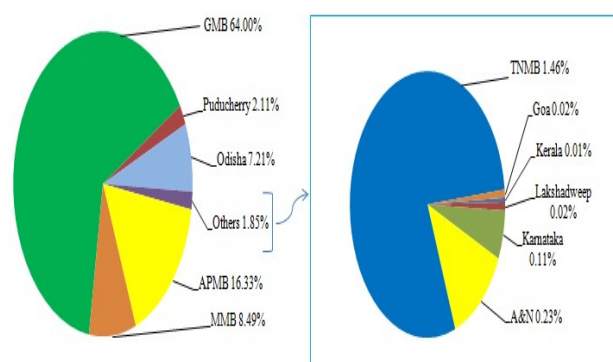
Share of Cargo handled by SMB/ DoP during April-June 2025-26

SMB/ DoP-wise cargo handling

Top performers during April-June 2025-26

- Top 5 SMB/DoP handled 98.15% of total cargo
- Maximum cargo handled by Gujarat Maritime Board (64.00%)
- Others (Goa, Kerala, Lakshadweep, Karnataka, Tamil Nadu and A&N Islands) handled only 1.85% of total cargo

Commodity-wise Cargo handled and its growth during April-June 2025-26

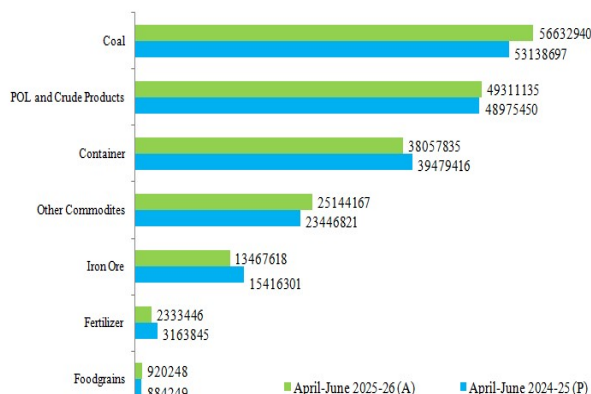
Commodity-wise cargo handled

Broadly commodities are categorized in 7 Principal commodities.

Progress during April-June 2025-26 vis-à-vis April-June 2024-25

- Coal had maximum (30.47%) share with 6.58% growth
- POL and Crude Products had 26.53% share with 0.69% growth
- Container registered 20.48% share
- Growth was maximum for Other Commodities (7.24%) with share of 13.53%.
- Growth was negative for Fertilizer (26.25%) and Iron Ore (12.64%)

Chart 8: Principal Commodity-wise Cargo handled during April-June 2025-26 vis-à-vis April-June 2024-25



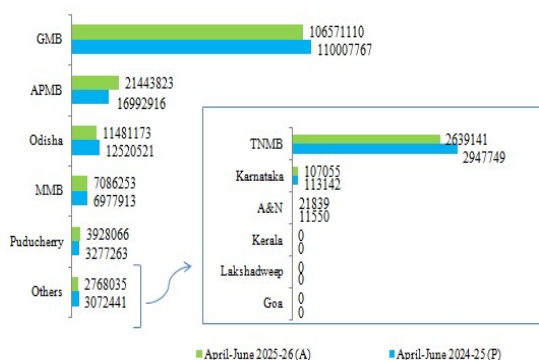
SMB/ DoP -wise Overseas Cargo handled during April-June 2025-26

Overseas Cargo handled by Non-Major Ports

Top performers during April-June 2025-26

- Top 5 SMB/DoP handled 98.19% of total cargo
- Maximum cargo handled by Gujarat (69.53%)
- Others (Goa, Kerala, Lakshadweep, Karnataka, Tamil Nadu, A&N Islands) handled only 1.81% of total cargo

Chart 9: Overseas Cargo handled by Non-Major Ports during April-June 2025-26 vis-a-vis April-June 2024-25



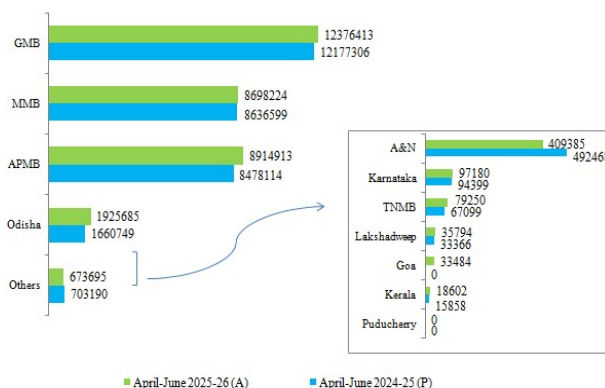

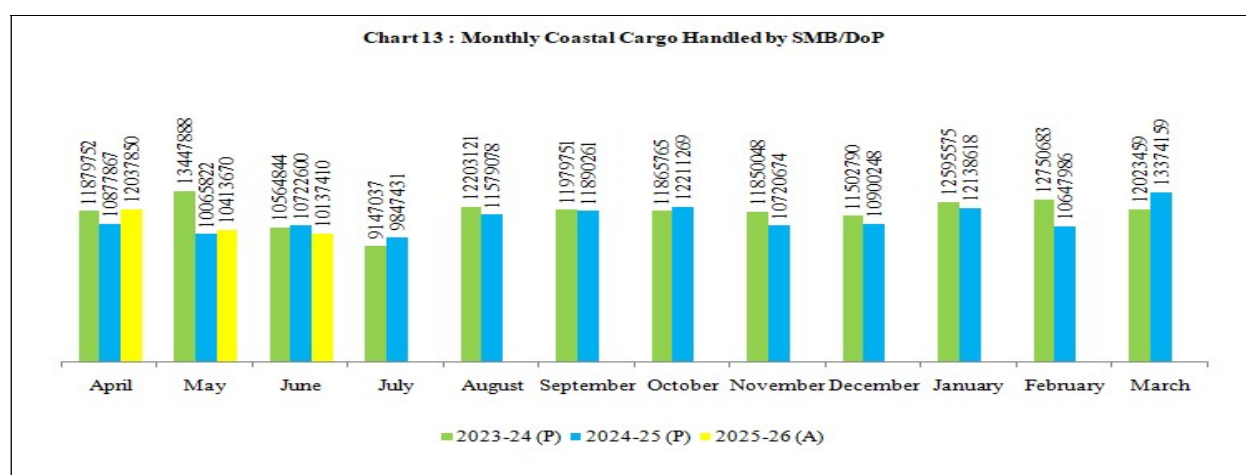
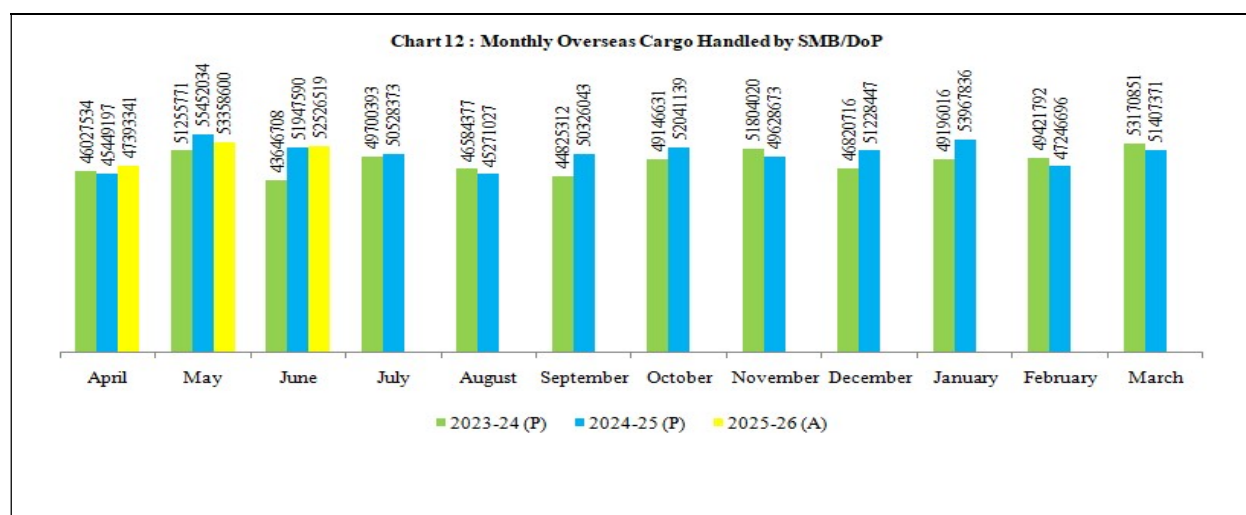
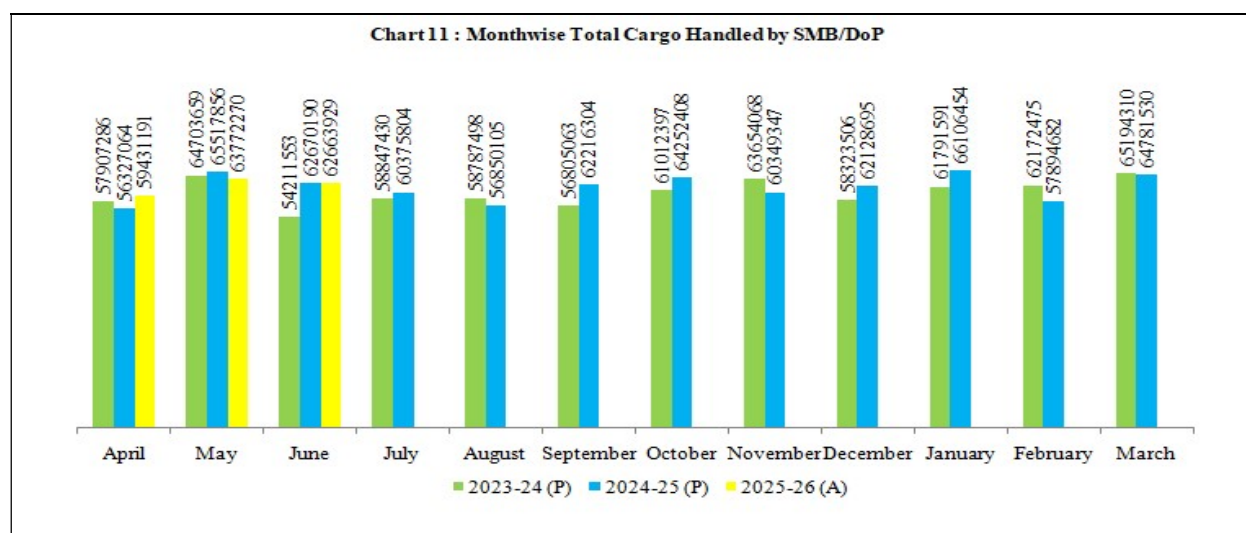
Top performers during April-June, 2025-26

- Others (Puducherry, Goa, Kerala, Lakshadweep, Karnataka, Tamil Nadu and A&N Islands) handled 2.07% of total cargo
